### Summoning of persons and Escort of patient

Unlimited

If the employee become acutely or seriously ill or gets seriously injured during their travels, the insurance covers expenses so that up until three persons can be summed. The insurance covers reasonable and additional expenses for their stay if the policyholder is hospitalised for a minimum of 2 days and is expected to be hospitalised two days after the arrival of the summed persons.

The insurance covers travel expenses if the employee is recalled to Denmark because of death or hospitalisation as a result of a serious injury or sudden occurrence of serious illness in the immediate family or if the employee has to return home because of fire, burglary etc. in his/her home. Furthermore, recall is covered if the employee is informed about serious and acute business events in his or her country of residence and the employee's presence is needed.

# Replacement

Unlimited

If the company needs to send another person to take care of the employee's work because the employee falls acutely and seriously ill for a minimum of 4 days, the insurance covers extra travel expenses for the replacement person.
